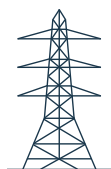
Der Smart-Meter-Adapter dient als Brücke zwischen dem privaten Heimnetzwerk des Anwenders und dem Smart-Meter des Netzanbieters. Er soll dem privaten Anwender eine einfache Möglichkeit bieten, die eigenen Zählerdaten zu erfassen und für eigene Zwecke zu verarbeiten.

Der Smart-Meter-Adapter arbeitet dabei nur „lokal“ und stellt von sich aus keine Verbindung zum Internet her.

Funktionsbeschreibung:



- Der Smart-Meter-Adapter dient als Schnittstelle zwischen dem Smart-Meter und dem Endkunden.
- Der Smart-Meter-Adapter empfängt die Verbrauchsdaten vom Smart-Meter und stellt diese über WLAN bereit.
- Die Daten werden am Dashboard angezeigt und können über JSON API, MQTT oder Modbus TCP abgefragt werden.
- Es werden alle gängigen Smart-Meter der österreichischen Netzbetreiber unterstützt.
- Die Entschlüsselung der Verbrauchsdaten findet im Adapter statt. Die notwendigen Schlüssel werden vom Netzbetreiber zur Verfügung gestellt.
- Die Versorgung erfolgt über USB oder, wenn es der Zähler unterstützt, durch den Zähler.
- Abnehmbare WLAN Antenne (SMA)
- Keine Speicherung von Verbrauchswerten im Adapter
- Einsatz nur in Innenräumen
- Die Anzeigemöglichkeiten variieren je nach Zählertyp und Netzbetreiber
- Zeitgleich werden nicht mehr als 3 Verbindungen zugelassen, bei verschiedenen Clients ist eine neue Anmeldung notwendig

Über ein konfigurierbares Topic werden die Zählerdaten im JSON Format an den MQTT Broker weitergereicht (Publish). Eine verschlüsselte Übertragung (MQTTS) mit TLS-PSK auf Port 8885 wird unterstützt. Dazu muss ein Zertifikat im PEM Format verwendet werden.

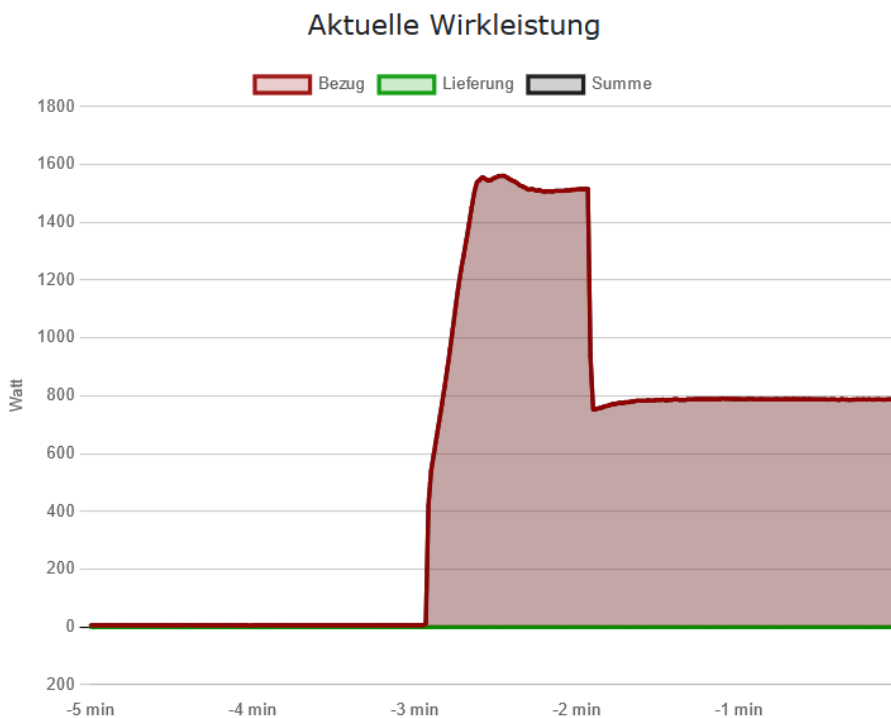
